**New Business:**

**A. 2025 MIHA Fees – Bob Clogg State fees will stay as they are for next year. 40, 80**

**B. Dates for Next Year's Regionals and Championship Meets, Regional Changed – Bob Clogg Regionals are down to 4 regions and again for this year. **D. Proof of Enrollment - Bob Clogg - D12 has done it, D1 this year. All coaches are to get and receive proof of enrollment: Any thing that guarantees that student rides for that school. Class school, ID, report card, letter from school. This is the responsibility of the Coach to make sure that they are compliant. Homeschool kids will ride for the school of residence. There will be some grey areas. Homeschool or on-line will default as to their residence.**

**E. Registered Horse – test run for Juniors - Bob Clogg - Due to an incident in past where horse was being used that was already used to another rider. The horse cannot be used by another rider or school. This will fall on the coaches. There is a form that will now be used as a google form this year for all horses used for MIHA. Coaches are responsible for filling out the form. Siblings can share a horse. Coggins number and blood draw will be required. Junior is a season and HS is another season. It will be posted under Rider Registration.**

**F. Team Rules – All coaches – for all rules to be enforceable the rules need to be submitted to the State and District Chair. If not received by the State, they cannot be enforced. Financials: When we lose a coach or DC – what do they have that has to be transferred to the new one. This information is to be placed on financials. Checking Account:**

**District, Region:** There needs to be an additional person on the account. Please get a second person on the account.
